### Climate Strategy Implementation Plan

In 2022 the Army published the Climate Strategy Implementation Plan (ICS-IP) to establish and meet goals of the Army Climate Strategy (ACS) and Executive Order (EO) 14057. EO 14057, signed December 8, 2021, outlines a coordinated, whole-of-government approach, along with Individual agency goals and actions, to transform Federal procurement and operations to reduce greenhouse gas (GHG) emissions and environmental impacts and secure a transition to clean energy and sustainable technologies. It establishes that the Federal Government will lead by example to achieve a carbon pollution-free electricity sector by 2035 and net-zero emissions economywide by 2050. The primary goals of EO 14057 are to achieve:

- 100 percent carbon pollution-free electricity on a net annual basis by 2030,
- 100 percent zero-emission vehicle acquisitions by 2035,
- A net zero emissions building portfolio by 2045,
- A 65 percent reduction in scope 1 and 2 GHG emissions from federal operations by 2030,
- Net zero operations from federal procurement,
- Climate resilient infrastructure and operations; and
- A climate and sustainability focused workforce.

To satisfy requirements of EO 14057, the ACS-IP focuses on near-term tasks, analysis, and planning that will lay the groundwork for future actions. Emphasis is placed on three Lines of Effort (LOE), developed to ensure completeness of the ACS-IP. Each LOE contains tasks which if executed successfully, will collectively achieve associated objectives. The three lines of effort are Installations, Acquisitions and Logistics, and Training. Initial Goals associated with the ACS-IP are centered on activities within FY2023 through FY2027. The majority of efforts outlined in ACS-IP will to be implemented and monitored at the enterprise level; however, local installations will likely bear some responsibilities. Ft. Novosel's DPW-ENRD is currently investigating potential opportunities to help reduce our climate footprint and are in the process of putting together a plan of action within the DPW-ENRD arena. Over the next few months you may be hearing more about the Army's Climate Implementation Plan so keep a look-out for it, and don't forget to do what you can to help make our environment a better place for the Army, our families and ourselves.
