FY17 Internal EPAS Audit Findings — 19-22 June

Fort Rucker has successfully completed another Internal EPAS Audit! Three teams assessed the status of Fort Rucker's environmental program using the USAACE Form 2717, Compliance Inspection Checklist. This resulted in 58 compliance findings with the majority dealing with POL. This was expected since historically POL findings are high and also because of the change in USAACE Form 2717, which added the old EMS documentation requirements to the program areas. The category of "Observation" was used to denote Hazmat issues that will be accessed in our upcoming FY18 External EPAS (27-30 November), but are not an inspection item on our USAACE Form 2717. 

Compliance Conner



The Compliance Corner is focusing on New Hazardous Waste regulations and our new FY18 Training Schedule this quarter. The Schedule is published on Sustainable Fort Rucker.

New HW Rules:

The EPA has revised the hazardous waste generator regulations under RCRA. The Hazardous Waste Generator Improvements Rule was signed on October 28, 2016 and published in the Federal Register on November 28, 2016. Over 60 changes to the hazardous waste generator regulations are included in the revision that clarify existing requirements, increase flexibility, and improve environmental protection. EPA-authorized states that run the RCRA program in their state are required to incorporate the more stringent provisions by July 1, 2018. ADEM advised to expect their guidance by Spring 2018. ENRD will disseminate information as soon as it is published. Stay tuned!
