

FY21 Internal EPAS Audit Results


On 3-6 May 2021, Fort Rucker successfully completed another Internal EPAS Audit! Two teams assessed the status of Fort Rucker's environmental program using the USAACE Form 2717, Compliance Inspection Checklist.

This resulted in 56 compliance findings with the majority dealing with POL. This was expected, since historically POL findings are high. Please see the graph and description of the findings on this page. Fort Rucker has successfully closed out 88% of all findings. Of the six remaining findings, five are associated with outdated training certificates and one with a missing Environmental Officer Appointment Memo. DPW-ENRD training courses are being sent out virtually on 13 July 2021. Personnel should be signed up by 12 July 2021. Registration is at Sustainable Fort Rucker (fortrucker-env.com).
