FY24 INTERNAL EPAS STATUS

The FY24 Internal EPAS identified and reported a total of 40 findings throughout the installation. Of these, 23 have been closed, leaving 17 findings still open, which accounts for 43% of the total. Among the open findings, there are approximately 8 Class I findings and 9 Class III findings.

The majority of the remaining open items pertains to the POL (Petroleum, Oil and Lubricant) media area.
