## NEW Integrated Environmental Performance Standard

New Army Integrated Environmental Performance Standard is replacing the current “EMS” guidance. In June, IMCOM published draft EMS Policy Guidance for Army Review. IMCOM is expected to publish final guidance for implementation by March 2017.

### Management Review

The EMS Management review was held in October with the Garrison Commander. It covered progress on meeting objectives and targets, inspection findings, changes in regulations, and overall environmental status. The outputs from the review were a increased focus on the compliance inspection repeat offenders and recycling program awareness.
